

# AIMS & OBJECTS

1. To organize seminars and awareness camps on human rights, consumers' rights, and protection of human and consumers' rights.
2. To open, manage, and run institutes, schools, and colleges.
3. To create a sense of brotherhood, mutual cooperation, trust, and communal harmony among the people.
4. To work for the upliftment of members irrespective of caste, creed, or religion and to help the poor and needy persons.
5. To open, manage, and run nursing homes, hospitals, and research centers.
6. To work for adult education and encourage children in the field of education and sports.
7. To educate people about their rights, and duties, and work for the eradication of social evils like dowry, bribery, smoking, drug addiction, and adulteration.
8. To organize social events and medical treatment/check-up camps for the people and help the poor and ailing persons by providing medical aid, medicines, etc.
9. To look after aged persons in old age homes/shelters and help widows.
10. To run libraries, reading rooms, dispensaries, hospitals, and training institutions for computers, fine arts, painting, yoga, etc.
11. To publish newsletters, books, charts, pamphlets, periodicals, and souvenirs to highlight the activities of the society.
12. To help unemployed youth find suitable jobs.
13. To accept gifts, grants-in-aid, and donations from any organization in consistency with the objects and activities of the society subject to the law of India.
14. To receive loans from any financial institution/bank or individuals whenever required for any specific purpose of the society.
15. To purchase land/buildings and any movable property for achieving the aims of the society.
16. To cooperate with any other society which has similar objectives for the welfare of people.
17. To work and adopt any welfare program announced by the Government of NCT in the future to fulfill the aims and objectives of the society.

18. All the income of the society shall be utilized towards the promotion of aims and objects of the society.
19. To perform all such acts as may be necessary for the achievement and accomplishment of the above-mentioned aims and objects.
20. To put all-out efforts to solve problems and to take up matters with competent authorities for the common interest of the people for providing and/or improving facilities in the area.
21. To make correspondence lawfully to arrange meetings, and conferences with the authorities concerned in the common interest of the people.
22. To provide help to the needy destitute, physically handicapped people, orphan children, incapable aged persons, widows, and the poor, without any distinction of caste, color, or creed.
23. To provide medical, financial, meals, clothes, and other amenities to needy people of NCT Delhi.
24. To organize educational programs to educate people about the policies of the Government of NCT Delhi and various laws/rules & regulations framed under the Constitution of India.
25. To arrange and organize social and cultural activities from time to time.
26. To establish and/or grant aid for the establishment and maintenance of parks and gardens, gymnasiums, sports institutions, and tube wells for the use of people in the areas.
27. To hold meetings, discussions, seminars, and discuss matters of social and cultural importance for better understanding and closer cooperation among people for the general upliftment of society.
28. To publish books, magazines, literature, and other publications for the encouragement of healthy social trends.
29. To accept donations, grants, and gifts, and to utilize the same for the fulfillment of the aims and objectives of the society.
30. All other social activities which are required for the attainment of aims and objects of the society.

## Note:

All the income, earnings, and movable/immovable properties of the society shall be solely utilized and applied towards the promotion of its aims and objects only set forth in the memorandum of the society. No profit thereof shall be paid or transferred directly or indirectly by way of dividends, bonuses, profits, or in any manner whatsoever to the present or past members of the society or to any persons claiming through any one or more of recent or past members of the society. No member of the society shall have any personal claim on any movable or immovable properties of the society or make any profit whatsoever by his/her membership.
